RESTOCKING: No materials are to be returned without our permission. All returned goods are subject to a minimum 15% restocking charge and MUST BE ACCOMPANIED BY THE INVOICE. All special orders are NOT returnable.

SERVICE CHARGES: Will be added to all balances over 30 days. A 1.5% per month service charge (18% per annum) on all accounts will be assessed.

RETURN CHECKS: All checks returned unpaid by your bank will be assessed a \$20.00 returned check charge.

CASH DISCOUNT: If issued on invoice, discounts are allowed only if paid on or before the 10th of the following month. Only issued cash discounts will be allowed. Any cash discount taken after the 10th is not allowed and will be charged back to your account.

PAST DUE: Your account is considered past due if payment is not received by the 25th of the month following statement date. Our monthly billing period runs through the 25th of each month.

DELINQUENT: Your account is delinquent and thus suspended if you have an unpaid balance 45 days old. At this time your account will be placed on C.O.D. status, to be reopened by payment or approval of the credit department.

LEGAL: Legal action will be taken on unpaid monies over 70 days, unless satisfactory arrangements are made with our credit department. All suits under this contract shall be brought in the courts of Franklin County, Ohio. You hereby agree to be responsible for all costs of collection, including attorneys fees incurred.

You hereby authorize Eastway Supplies, Inc. to obtain reports to be used in connection with this application and to obtain further credit information upon the listed Applicant, its owners and/or officers. This authorization shall be continuing during the entirety of the account with Eastway Supplies, Inc.

You agree to provide Eastway Supplies, Inc. with notice of any changes in the information contained herein, and such notice shall be provided by certified mail, return receipt requested.
